PROJECT SCOPE DISCUSSION

The scope of the NRF Production Support Complex 3rd Floor Development GPP consists of developing the large open finished space on the PSC 3rd floor to provide professional occupant work spaces for approximately 165 office workers. This will include approximately 25 individual offices as well as approximately 140 systems furniture office work spaces. The work space layout will essentially copy the existing PSC 2nd floor work space layout. The original 3rd floor design and construction was completed with the intention of copying the 2nd floor work space layouts, such that utility system modifications would be minimized.

The project does not violate applicable regulatory requirements, require construction or major expansion of waste handling facilities, result in unpermitted releases of hazardous substances, or adversely affect environmentally sensitive resources, including wetlands. The project does not involve genetically engineered organisms or species. There are no extraordinary circumstances related to the proposed action. The project has not been segmented to meet the definition of a categorical exclusion and is not connected to other actions with potentially significant and/or cumulative impacts.

CONCLUSION

The NRF Production Support Complex 3rd Floor Development GPP is categorically excluded from additional NEPA documentation under 10 CFR1021 Subpart D, Appendix B, B1.15. Specifically, the categorical exclusion that applies is the following:

B1.15 Support buildings

Siting, construction or modification, and operation of support buildings and support structures (including, but not limited to, trailers and prefabricated and modular buildings) within or contiguous to an already developed area (where active utilities and currently used roads are readily accessible). Covered support buildings and structures include, but are not limited to, those for office purposes; parking; cafeteria services; education and training; visitor reception; computer and data processing services; health services or recreation activities; routine maintenance activities; storage of supplies and equipment for administrative services and routine maintenance activities; security (such as security posts); fire protection; small-scale fabrication (such as machine shop activities), assembly, and testing of non-nuclear equipment or components; and similar support purposes, but exclude facilities for nuclear weapons activities and waste storage

activities, such as activities covered in B1.10, B1.29, B1.35, B2.6, B6.2, B6.4, B6.5, B6.6, and B6.10 of this appendix.
